Meeting called to order by Chairperson Bonnie Schwam at 6:45 PM

Reviewed August 24, 2009 Minutes. Bill motioned to approve minutes. Bonnie and Tara voted in favor of approving the minutes.

Old Business:

A retraction was made in the Perry Park Sentinel about the 4th July celebration. Brief but there.

The council approved two people from Parks and Rec to go to boards and commissions' seminar but it was cancelled. It will be rescheduled later in the year.

Korrie will be asked to look into cost of woodchips for the new playground.

Christy Cash's application for board alternate will be submitted no later than October 1st

Bill said that the Picnic shelter and Pavilion are now complete along with the volley ball court.

Concrete picnic tables and benches are being brought in from rest areas. Approximately 16 are coming. 14 metal tables have been moved into the Pavilion and Picnic shelter. Metal tables will not be bolted down to allow them to be moved around.

Bonnie asked where the railroad ties she donated were. Bill will look into it.

Planning:

Bill will be preparing an article to the sentinel about what is going on in the Park. Tara has taken pictures and will be emailing them to Bill to add to the article.

Bill will have square footage available for playground equipment by next meeting to allow the playground equipment committee to look at appropriately sized play equipment. Tara will contact committee to start to go through brochures and other material.

Bill showed pictures of a climbing net as an alternative to climbing boulders. He also suggested looking at climbing walls and looking at Tawplay.com

Council approved decorative lighting for the back of Park but will wait on deciding possible lightening along Spruce Mt Rd.

The council approved a second restroom for the Park. This restroom will go where the handicapped porta potty is by the loop at the picnic area.

An email reminder will go out to remind everyone to please submit volunteer hour's to Sharon Roman at Town Hall. The deadline is Friday.

A chairperson for the tree lightening ceremony needs to be appointed. We propose to have trees adopted by businesses to decorate similar to last year. Bonnie will contact the Chamber to see if they would like to be involved in this event.

Due to a meeting taking place in the Town Hall we have been asked to cancel or move venue. Matt is going to look into changing venue so we can keep moving forward.
