- Matias Cumsille read the development updates provided by Heather Yanda.
  - 255 Upper Lake Gulch Road/Travel Center
    - We have received all of the agency referrals back and delivered them to developer and their engineers.
    - GMS signed off on the grading permit, and that was issued.
    - Three out of four (potentially five) variance requests are being presented to Town Council this Thursday so they can adjust their plans if needed
  - o 9138 Spruce Mountain Road/Emerson Knives
    - Land Use Application submitted two weeks ago along with deposit and site plan fee. Emerson Knives is an international company that manufactures custom knives (for retail sales and for military use...Navy Seals use them). They are going to use the basement for the assembly of knives (not manufacturing), and the upstairs will be an artisan shop, where they sell their knives as well as high-end artisan merchandise. The front of the building will look like an old-time general store.
  - 233 Perry Park Annexation/Special Events Facility



Completed Annexation Petition Application and paid deposit a couple months ago.
 We met with them to discuss the process and gave next steps. Heather sent follow-up email a couple weeks after the meeting. Haven't heard from them since them.
