PRESENTATION OF APPLICATION: Sharon Roman presented the liquor license application with supporting materials to the Council.

PUBLIC COMMENTS:

- Toni Reynolds Asked if there has been a Building Permit issued yet, too early in her opinion to apply for a liquor license with no building, encourages the Town to do a full study on economic development for this business. Revenue is good for the Town but what about additional expenses i.e. Law Enforcement cost, road maintenance, etc.
- **Jim Ingwersen, Owner of Hops and Vines** Asked the Town to think about the affect on the proposed strategic plan, risky, sets a precedent, bad idea...

COUNCIL COMMENTS:

• **Isaac Levy** – Concerned that the applicant only got six signatures in favor of Liquor Store, would like more public input from Town Residents.

- **Jeremiah Holmes** Would also like to hear more from Town Residents.
- Jennell Waggle Very concerned about the security of the licensed premises when closed.
- Gerry Been In favor of Licensing the Liquor Store

COUNCIL ACTION: A motion was made by Gerry Been and seconded by Tabitha Parks to approve the Retail Liquor License submitted by Ape Rock Spirits, LLC. Town Attorney Scot Krob added these three conditions to me met before license is actually issued.

- 1. CO (Certificate of Occupancy) must be issued to Owner before license issued.
- 2. Owner must provide an updated drawing of licensed premises which would be submitted to Town Manager Matt Krimmer for approval by him and Council.
- 3. Demonstrate security of licenses premises when store hours are not in effect that is satisfactory to Council

A roll call vote was taken. Seven (7) in favor, zero (0) against; motion carried.

ADJOURN: Jennell VanGorder made a motion to adjourn the Public Hearing which was seconded by Jeremiah Holmes. Motion carried by unanimous voice vote 7-0-0. Mayor Been adjourned the public hearing at 5:37 p.m.
