COLORADO DEPARTMENT OF TRANSPORTATION (CDOT) PRESENTATION – I-25 GAP Expansion Project

Chuck Attardo, CDOT, began an interactive slide presentation on the project
addressing questions and comments from the audience as he proceeded through
the slides. Chuck was supported by Aaron Greco, CDOT, in responding to
questions.

Numerous questions were asked with many of them focusing on the proposed "express (toll) lane". The majority of comments expressed overwhelming opposition to adding a toll lane. By a show of hands all but three (3) audience members opposed the toll lane. Other questions and comments addressed project

costs, long range planning, prudent use of State and Federal monies, building for future growth, wildlife concerns, interstate speeds and traffic enforcement.

Sandy McKeown made a motion to approve regular council meeting minutes for February 1st, 2018. The motion was seconded by Jeremiah Holmes. Motion carried by unanimous voice vote 5-0-2.

Sandy McKeown made a motion to approve a sign permit for Elevate Construction. Heather Sanchez seconded the motion which then passed by unanimous voice vote 5-0-2.

A motion was made by Jeremiah Holmes and seconded by Heather Sanchez to adjourn the Council meeting. Motion carried by unanimous voice vote 5-0-2. Mayor Gerry Been adjourned the Council meeting at 8:06 p.m.
