### **SCHEDULED PUBLIC APPEARANCES:**

• Zack Schmidt, Thrive Broadband, addressed the Council on behalf of Doug Look to request an extension of the Temporary Structures Permit for the property at 410 Plum Creek Avenue. Six month extension was granted.

## **UNSCHEDULED PUBLIC APPEARANCES:**

• Marvin Cardenas requested the Council eliminate the Deputy Town Manger position and demanded an immediate motion be made to implement the action. Council scheduled a public workshop on January 10<sup>th</sup> 2019 at 6 p.m.to discuss the matter.

## **MOTIONS:**

Paul Bowers made a motion to approve a six-month extension of the Temporary Structures Permit for the Doug Look property at 410 Plum Creek Avenue. for use by Thrive Broadband subject to completion of the privacy fence enclosing the property with no more than a 20 ft. wide entrance and assuring that the fence is maintained in a satisfactory condition. The motion was seconded by Jeremiah Holmes and a passed by voice vote 6-0-0.

A motion was made by Jennell Waggle and seconded by Tabitha Parks to approve payment of General Fund bills in the amount of \$61,092.54. A roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

Tabitha Parks made a motion to approve payment of bills for Water and Sewer expenditures totaling \$26,772.40. Jennell Waggle seconded the motion. A roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

A motion was made by Jeremiah Holmes and seconded by Jennell Waggle to approve Resolution 18-19, A RESOLUTION AMENDING THE 2018 BUDGET FOR THE TOWN OF LARKSPUR. A roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

Jennell Waggle made a motion to approve Resolution 18-20, A RESOLUTION TRANSFERRING SUMS OF MONEY TO DEFRAY EXPENSES WITHIN THE WATER AND SEWER FUND OF THE 2018 AMOUNTS BUDGETED FOR THE TOWN OF LARKSPUR, COLORADO. The motion was seconded by Tabitha Parks. A roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

A motion was made by Jeremiah Holmes and seconded by Heather Sanchez to approve Resolution 18-21, A RESOLUTION LEVYING A TAX OF 15.00 MILLS AND CERTIFYING SAID MILL LEVY TO THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY. A roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

A motion was made by Jennell Waggle to approve Resolution 18-22, A RESOLUTION TRANSFERRING SUMS OF MONEY TO DEFRAY EXPENSES WITHIN THE WATER AND SEWER FUND OF THE 2018 AMOUNTS BUDGETED FOR THE TOWN OF LARKSPUR, COLORADO. The motion was seconded by Jeremiah Holmes and a roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

Heather Sanchez made a motion to approve Resolution 18-24, A RESOLUTION TRANSFERRING SUMS OF MONEY FROM THE GENERAL FUND OF THE 2018 AMOUNTS BUDGETED FOR THE TOWN OF LARKSPUR, COLORADO. The motion was seconded by Jeremiah Holmes and a roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

Mayor Gerry Been made a motion to approve council public hearing meeting minutes for November 15<sup>th</sup>, 2018. The motion was seconded by Jeremiah Holmes. Motion carried by unanimous voice vote 5-0-1.

A motion was made by Jeremiah Holmes and seconded by Jennell Waggle to approve regular council meeting minutes for November 15<sup>th</sup>, 2018. Motion carried by unanimous voice vote 5-0-1.

Heather Sanchez made a motion to accept a liquor license application from Timothy Dumler, dba Ape Rock Spirits, LLC, and set a Public Hearing date of January 17<sup>th</sup>,

2019, preceding the regular Council meeting, at 5:30 p.m. The motion was seconded by Paul Bowers. Motion carried by unanimous voice vote 6-0-0.

Jeremiah Holmes made a motion to declare Town Hall closed December 24, 2018, Christmas Eve, and December 31, 2018, New Years Eve. The motion was seconded by Tabitha Parks. A roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

Jeremiah Holmes made a motion to direct Town staff to purchase a plaque honoring Jim and Kat Fesing, aka Mr. and Mrs. Santa Claus, for their many years of volunteering at the Town's Annual Tree Lighting Ceremony. The motion was seconded by Tabitha Parks. A roll call vote was taken. Six (6) in favor, zero (0) against; motion carried.

A motion was made by Mayor Gerry Been and seconded by Jeremiah Holmes to adjourn the Council meeting. Motion carried by unanimous voice vote 6-0-0. Mayor Gerry Been adjourned the Council meeting at 8.:13 p.m.

**ACCOUNTING:** General Fund and Water and Sewer Fund bills for \$61,092.54 and \$26,772.40, respectively, were approved. The Council also approved Resolutions 18-19, 18-20, 18-21, 18-22, and 18-24 completing year end fund transfers, adjusting the 2018 budget, and setting and certifying the Town's Mill Levy.

**SEMOCOR REPORT:** Paul Grant presented the October 2018 report.

- **Planning Commission** (**PC**) Marvin Cardenas, Chair, informed the Council that the next PC meeting is scheduled for Monday, Dec. 10<sup>th</sup> at 5 p.m.
- Water and Sewer Board (W&S) Trish Bernhardt, Chair, informed the Council that additional information regarding the planned wastewater treatment plant has been requested from Town staff and the next W&S Board meeting is scheduled for December 13<sup>th</sup> at 6 p.m.
- Parks and Recreation Board (P&R) Ralph Marsh, Chair, was unable to be present, however Matt Krimmer informed Council that the next P&R Board meeting has been scheduled for January 8 at 4:30 p.m. and that all board members played an active part in the Dec. 1<sup>st</sup> tree lighting.
