**MINUTES FROM PRIOR MEETING:** A Motion to approve the Meeting Minutes from 2-11-19 was made by Matias Cumsille and seconded by Brian Cook. A roll-call vote was taken with Four (4) in favor; Zero (0) against; Zero (0) abstention; Motion carried.

#### **MOTIONS:**

The motion was seconded by Brian Cook. A roll-call vote was taken. Three (3) in favor, One (1) against (W. Lucero); (0) abstention; Motion carried.
