**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF
LARKSPUR APPROVING THE RENEWAL OF CURRENT
AGREEMENTS FOR SERVICES IN AND FOR THE TOWN OF
LARKSPUR**

WHEREAS, the Town Council for the Town of Larkspur is authorized, pursuant to the Town's Home Rule Charter, the Colorado Constitution, and state law, to administer the affairs of the Town of Larkspur (the "Town"); and

WHEREAS, the Town Council has historically, repeatedly, and consistently utilized the professional services of certain vendors (the "Known Vendors") within the Town of Larkspur for various services through various agreements (the "Agreements"); and

WHEREAS, the Agreements with the Known Vendors generally expire annually and are renewed in January of each year; and

WHEREAS, the Known Vendors have agreed to continue their service to and for the Town with the scope of services as provided in the Agreements attached hereto; and

WHEREAS, the Town finds it in the best interest of the Citizens of the Town to continue the long-established relationships for services from the Known Vendors as reduced to writing in the various Agreements.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF LARKSPUR, COLORADO, AS FOLLOWS:**

Section 1. The Agreements between the Known Vendors listed below, and the Town of Larkspur are hereby approved in substantially the same form as attached hereto, subject to final approval by the Town Attorney. Upon such approval, the Mayor is authorized and directed to execute each Agreement on behalf of and for the benefit of the Town.

Section 3. Severability: If any Article, Section, paragraph, sentence, clause, or phrase of this Resolution is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining portions of this Resolution. The Board of Trustees declares that it would have passed this Resolution and each part or parts thereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

Section 4. Repeal: Existing Resolutions or parts of Resolutions covering the same matters as embraced in this Resolution are hereby repealed and all Resolutions or parts of Resolutions inconsistent with the provisions of this Resolution are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any Resolution hereby repealed prior to the taking effect of this Resolution.


