

TOWN OF LARKSPUR RESOLUTION NO. 2019-12

A RESOLUTION APPENDIX A OF SECTION 13-2-140 OF THE LARKSPUR MUNICIPAL CODE TO INCREASE WATER SERVICE FEES

WHEREAS the Larkspur Town Council, pursuant to Colorado statute and the Larkspur Town Charter, is vested with the authority of administering the affairs of the Town of Larkspur, Colorado (the "Town"); and

WHEREAS, in order to promote orderly development and to protect the health, safety and welfare of its citizens and to maintain water facilities for the benefit of the community the Town provides water service to its residents and visitors; and

WHEREAS, the Town Council has determined that it in light of the increased costs of providing water service, it is in the best interest of the Town to preserve its ability to continue to provide water service in the future to increase the fees for such service to reflect the increase in the costs of such service; and

WHEREAS, fees for water service, as well as other services, are set forth in Appendix A to Section 13-2-104 of the Town Code (the "Fee Schedule"); and

WHEREAS, the Fee Schedule may be amended by resolution of the Town Council.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LARKSPUR, COLORADO AS FOLLOWS:

1. Appendix A, Section 13-2-140 is hereby amended by removing the **bold strikethrough** language and adding the **bold underlined** language to read in its entirety as follows:

The fee set forth above for Section 13-2-140 "Water service 8,000 gallons per ¾" equivalency" in the amount of \$38.50 as of the date of this Resolution, shall be increased annually by 5% each year commencing January 1, 2021 and continuing through December 31, 2024 unless otherwise amended by Resolution of the Town Council.
