RESOLUTION NO. 2020-07**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF
LARKSPUR TO CANCEL THE APRIL 07, 2020 REGULAR MUNICIPAL
ELECTION AND DECLARE THE CANDIDATES ELECTED UNDER
CERTAIN CONDITIONS**

WHEREAS, pursuant to C.R.S. § 31-10-507, the Town may by ordinance require an affidavit of intent for write-in candidates and may by ordinance provide for the cancellation of elections if the only matter before the voters is the election of persons to office and there are not more candidates than offices to be filled, including candidates filing affidavits of intent;

WHEREAS, the Town has done so at Section 2-1-20 of the Larkspur Municipal Code;

WHEREAS, the Town of Larkspur Town Council passed the Emergency Ordinance 2020-02 to amend the Affidavit of Intent of Write-In Candidate deadline to comport with C.R.S. § 31-10-306 requirements and takes effect immediately following its passing; and

WHEREAS, the Town of Larkspur's Regular Municipal Election is scheduled to be held on April 07, 2020.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF LARKSPUR, COLORADO, AS FOLLOWS:**

Section 1. As of the close of business on the sixty-fourth day before the election, the Town had received the same number of candidate petitions as the number of offices to be filled at the April 07, 2020 Regular Election, and had received no write-in candidate affidavits of intent.

Section 2. Pursuant to Section 2-1-20 of the Larkspur Municipal Code, the Town Council hereby directs the Town Clerk to cancel the April 7, 2020 Regular Election and declares the following candidates elected to the following offices for four-year terms:

Section 3. The Town Clerk is further instructed to provide notice of this cancellation and election as required by Section 2-1-20 of the Larkspur Municipal Code by posting at each polling place and in not less than one other public place, and published, if possible.


