PRESENTATION OF APPLICATION: **Dannah Koeniger** presented documentation with supporting materials on the Towns' application for the **Community Development Block Grant (CDBG) to the Town Council**. Scope, Funding, Rate Adjustments, Schedule, Environmental Impacts were covered. There were two options for funding presented.

PUBLIC COMMENTS:

- **Ed Blanchard** asked about cost of new water treatment plant, asked about final cost and coverage to build new plant that was supposed to remove radium from the Town water Supply. Concerned about accountability moving forward and how do we deal with the bill of goods we were sold, what recourse do we have? Gave examples of observed issues with new plant.

COUNCIL COMMENTS:

- **Mayor Cardenas** discussed the fact that based on the recent Water Study we will not need to replace water system infrastructure which is a huge savings for the Town.
- **Councilmember Buss** had question about the towns Kick Blocks conditions, Dannah discussed the process for replacement. Councilwoman Buss asked for more info on findings on pipe replacement. Dannah explained process and findings.
- **Councilmember Teague** asked about pressure in the water lines as it relates to the Kick Backs due to projects that are currently underway in the Town. Dannah held off answering this as she is covering system pressure later in her presentation.
- **Mayor Cardenas** recommended putting off the replacement of the 12-inch main and focusing on the Radium removal from the water system and applying for the lesser Grant amount.
- **Councilmember Buss** asked question about waterline replacement and recourse from Wright Water Engineering asked for help from councilmembers Levy and Councilmember McKeown, Councilmember Levy explained that he did not think that at that time they opted for all the bells and whistles, Mayor suggested that they table that discussion for another time for the sake of time.
- **Councilwoman McKeown** asked about loop location on Spruce Mountain Rd. Dannah gave explanation.
- **Mayor Cardenas** informed council that the water and sewer board approved the lower Grant.
