- Semacor Update-

Larkspur Water and Sewer Issues and Prioritizations July 14, 2021

Short Term

Upper Water Tank repairs

To be done late 2021 after Renaissance Festival is over \$60k was previously approved by Council No further action needed by Council

Lower Gate Pressure relief valve in water system pipeline

Needs to be replaced Approximate 10 inch valve Cost should be minimal

New Water Tank Maintenance

Cathodic protection needed for the new water tank
Will has a cost estimate from a subconsultant, Aegion for \$680.
Work should be done this year and will need to be done annually.
Council needs to approve the cost

Wastewater treatment plant- Collection Check valve #2

Approximately 43 years old; Needs to be replaced Cost is approximately \$15k
Council will need to approve the cost once Will has an appropriate bid from a subcontractor

Long Term

Generator needed for Water Treatment Plant

Power surges this year have caused outages to water supply Large diesel generator needed to prevent this and to provide for emergencies. Approximate cost of \$250,000 needs to be budgeted or grant money identified

Upgrades to waste water treatment system

By about 2025, CDPHE is going to have more stringent restrictions for wastewater. One issue is that the water treatment plan creates backwash/waste that is high in radium, all of which goes to the waste water treatment plant. Estimated cost for an upgrade to the WWTP is \$6 to \$9 Million Town needs to begin planning for this.

Replacement of Arapahoe Well

Arapahoe Well #1 on the hill is not functioning

Replacement should be considered, and potentially in a different location since the two Arapahoe wells are close in distance

Will's estimated cost for drilling, permitting and engineering is \$700,000 Town should consider planning for a new well.

Will stated that the two functioning wells are now producing at their maximum capacity. As shown in the June 2021 report, the two wells are just keeping up with the current demand.

Consideration of Grant Writing contractor

There was discussion about the need to obtain the services of a grant writer, particularly for the first item on the long term list of purchasing a generator for the water treatment plant.

It was also discussed that some grants have not been available to Larkspur, until and unless the residents pay their fair share of water and sewer rates. The Board would like that issue analyzed further and a discussion was held of ideas to increase rates, yet possibly offer subsidies to those residents who cannot pay.
